FACTS Tuition Management

It is required that all families contract with FACTS Tuition Management Services, unless tuition is paid in full. FACTS works with more than one million families at approximately 5,000 schools to set up monthly payments through automatic bank or credit card deductions. August-July payments will be set up the 1st of each month through FACTS. There is a yearly fee of \$45.00 to start the contract with FACTS. STATEMENT OF DOCTRINAL BELIEFS

As stated on the Parent/Guardian Statement of Support, the parents and/or guardians and the student *acknowledge receipt* of these doctrinal beliefs. Each faculty member also signs a statement affirming his or her adherence to these doctrinal positions.

- 1 **THE SCRIPTURES**: We believe the entire Bible; all 66 books of the combined Old and New Testaments are verbally inspired by God and are inerrant in the original writings. Through the providence of God, the Word of God has been protected and preserved, and is the only infallible and authoritative rule of faith and practice (2Timothy 3:16-17; 2 Peter 1:20-21).
- 2 **GOD**: We believe there is only one true, living sovereign, holy, and eternally existent God. He exists in three co-equal persons – Father, Son, and Holy Spirit – each being a distinct person and with a distinct function, but all of one essence and all possessing the same nature, perfection, and attributes. The triune God is the creator and sustainer of all things, the source of all truth, and is worthy of worship, confidence, and obedience (Deuteronomy 6: 4-5; Genesis 1:31).
- 3 **JESUS CHRIST**: We believe Jesus Christ is God. He was conceived by the Holy Spirit, born of a virgin, lived a sinless life, performed many miracles, shed His blood on the cross to pay the debt for our sins, was buried, bodily resurrected, ascended to the right hand of the Father, and will return literally, visibly, and personally in glory and power. (John 1:1-3, 14; Matthew 1:18-25; Philippians 2:5-9; Colossians 1:15; 1 Corinthians 15:1-8; Acts 1:11).
- 4 **HOLY SPIRIT**: We believe the Holy Spirit is God, co-equal and co-existent with the Father and the Son. He is the chief convictor of sin, the chief agent of regeneration and sanctification. The Holy Spirit lives within every believer and empowers every believer to live a godly life. (John 14:16-19; 16:7-15; 1 Corinthians 6:19-20; Romans 8:9, 11; Titus 3:5).
- 5 **MANKIND**: We believe that in the beginning God created mankind in His image, and is not in any sense the product of evolution. Mankind was originally created with the ability to live perfectly for God's glory (Genesis 1:27, 31).
- 6 **SIN**: We believe Adam, the first man, sinned by disobedience. This act resulted in the fall of all mankind, therefore, all people have sinned and lost their ability to live for the glory of God. Every person's in incurs both physical and spiritual death until there is forgiveness and salvation by the grace of God (Genesis 3:1-24; Romans 3:10 -23; 5:12-21; 6:23).
- 7 **SALVATION**: We believe the salvation of lost and sinful people is a free gift of God's grace apart from human works, based solely upon Christ's vicarious and atoning death, effected by the regenerating work of the Holy Spirit, and received only through faith in the person and finished work of Jesus Christ on the cross and His resurrection from death (Ephesians 2: 8-10; 2 Corinthians 5:21).
- 8 **THE CHURCH**: We believe the church is the body of Christ and the family of God. It is made up of saved and baptized believers, who regularly join together for worship, fellowship, and ministry (Matthew 16:18; 1 Corinthians 12:12-14; Hebrews 10:25).
- 9 **EVANGELISM**: We believe it is the responsibility and privilege of every Christian to proclaim the **good news of Jesus Christ and to seek to make growing disciples (Matthew 28:18-20; Acts 1:8).**
- 10 **THE HOME**: In addition to these important beliefs, we also believe God has given the parents and the home the responsibility to bring up their children in the nurture and admonition of the Lord (Ephesians 6:4; Proverbs 22:6). We believe a consistent and whole education will occur when home, church, and school work closely together and are in agreement on the basic concepts of life.

- 11 We will be faithful to attend all parent functions at **Evangel Christian School**, as best we can. These include Open House, Parent Teacher Fellowship meetings, parent conference requests, information nights, etc.
- 12 If we become dissatisfied with **Evangel Christian School** in any way, we will strive to resolve the matter with the person (s) involved as privately and lovingly as possible, rather than spreading criticism and negativism (Matthew 18:15-17; 5:23-24).
- 13 We will seek to support and advance **Evangel Christian School** in every area possible – spiritually, academically, physically, and financially.

NOTE: Thank you for receiving and reading these basic beliefs. Even if some (or even all) of these are not your personal beliefs, we feel it is very important for you to know what the school believes and what your child will be taught.

COVENANT

A covenant is a binding agreement between two parties. It signifies a solemn oath and sincere pledge of mutual respect and cooperation. **Evangel Christian School** covenants to provide the best it can for your children in the way of facilities, curriculum, faculty, athletics, social functions, and instruction. The school further pledges to do all possible to support your home in growing every student in the nurture and admonition of the Lord.

As the legal parents/guardians of our children, we covenant to support **Evangel Christian School** in its efforts at Christian education. AFTER SCHOOL CARE PROGRAM

All students in the K-6th grades who are on the property after 3:15 are required to be in this program unless they are with a teacher or coach in an authorized after school activity. **THE TEACHER OR COACH MUST BE PRESENT AT THAT TIME.** This is for the safety of your child.

Children of faculty, housekeeping, and all other staff members must be in after school care program, unless they are with parents.

Children waiting for practices to begin or are waiting to be picked up after practice are still required to be in the program.

A separate completed registration form is required for every child entering the program. Information must be updated on a regular basis. Contact the office for an application.

The rate must be set up on debit or credit card and paid weekly.

There will be no charge if your child is picked up by 3:15.

The after school program is available from 3:00 p.m. until 6:00 p.m. for K – 6th grades. Parents must be on time to pick up their children. Additional charges apply **per minute** after 6:00 p.m. This charge must be paid when you pick up your child.

THERE WILL BE NO AFTERCARE FOR MIDDLE OR HIGH SCHOOL STUDENTS. All middle and high school students must be picked up immediately after school or go directly to a sport with their coach present. They are not allowed to stay in the building past 3:15 unsupervised.
